**General Architectural Description:**

The building at 708 W Marvin Ave is a two-story single-family house built in 1913, according to the historical marker associated with the property. The property was originally built for residential purposes, and its use remains unchanged. The primary exterior material is wood. The building exhibits elements that are suggestive of the Colonial Revival style, a popular architectural style of the early twentieth century that incorporate features seen on buildings dating back to the colonial era of eastern states. The building has a massed plan, a form that is multi-rooms deep and multi-rooms wide, often with a rectangular footprint. The building has double-hung windows. The building has a single-door primary entrance. Porch feature(s) include the following: classical columns. Landscape feature(s) include the following: plantings. The only ancillary building on the property is a shed.
